## Call for Délinę Got'inę Government Dene Gha Gok'a réhkw'ı (Beneficiary Board) Nominations

Notice is given to the Déline Beneficiaries of the Sahtu Dene and Metis Comprehensive Land Claim Agreement that appointment for the first Dene Gha Gok'ə réhkw'ı (DGGR or

Beneficiaries Board) Members of the Déline Got'ine Government will take place on September 1, 2016.

The DGGR provides recommendations to the Déline K'aowədó Kə (DKK or Main Council) when making decisions on land claim rights, lands and financial assets. Four members will be appointed. The <code>pekw'ahtidaé will</code> also serve as a DGGR member. The appointments are for a term of two years.

All Beneficiaries, regardless of where they live, can nominate another Beneficiary to sit on the DGGR. All Beneficiaries will also be able to review the nominations and provide comments. Following the comment period, the <code>pekw'ahtida</code> and the DKK will appoint the four DGGR members from among those nominated. At least two members must be non-resident Beneficiaries.

Nominees are required to meet the following criteria:

- Be a Beneficiary member of the Sahtu Dene Metis Comprehensive Land Claim Agreement and a member of the Déline Land Corporation;
- Be at least eighteen (18) years of age as of the Effective Date (September 01, 2016);
- Not have been convicted of a fraud-related crime at any time; and,
- Not have been convicted of an indictable offence within the past five years.

Nominees will be assessed on how their education and/or knowledge and experience will benefit the DGGR and how their participation on the DGGR will contribute to its success. This will be based on their CV, personal statement, and any confidential comments received from Beneficiaries. Nominators may nominate no more than one person.

## Nominations for appointees as DGGR Members must be received <u>before</u> 11:59 p.m. on Monday, July 11, 2016.
