NOTICE OF THE DÉL̄NĒ FINAL SELF-GOVERNMENT AGREEMENT RATIFICATION VOTE

TAKE NOTICE THAT a vote will be held from March 10, 2014 to March 12, 2014 to ratify the Dél̄nę Final Self-Government Agreement (FSGA) between the Dél̄nę First Nation and the Dél̄nę Land Corporation and the Governments of the Northwest Territories and Canada.

AND FURTHER TAKE NOTICE THAT the question which voters will be asked to vote on is:

“Having had full opportunity to review and consider the Dél̄nę Final Self Government Agreement, do you agree to the Ratification of the Dél̄nę Final Self Government Agreement?”

AND FURTHER TAKE NOTICE THAT an eligible voter as determined within the FSGA as:

- a) every person who will be at least eighteen (18) years of age before the final day of the vote and who is a member of the Dél̄nę Land Corporation or the Dél̄nę First Nation Band who is not:
 - b)
 - i. also a member of a land corporation established pursuant to the Sahtu Dene and Metis Comprehensive Land Claim Agreement other than the Dél̄nę Land Corporation, or
 - ii. enrolled in another land claim or self-government agreement in Canada.

AND FURTHER TAKE NOTICE THAT information sessions will be held on

February 11, 2014 from 1 to 5 p.m. and 7 to 9 p.m. at the **Tree of Peace in Yellowknife, NT** and;
February 12, 2014 from 1 to 5 p.m. and 7 to 9 p.m. at the **Dél̄nę Arena in Dél̄nę, NT**

where representatives from the parties will present information on the Ratification Vote and on the contents of the FSGA;

AND FURTHER TAKE NOTICE THAT the Official Voters list will be posted in the Communities of Dél̄nę and Yellowknife and in any other place or by any other method as determined by the Ratification Committee on or before the 23rd day of January, 2014;

AND FURTHER TAKE NOTICE THAT voters may vote either by a mail-in ballot or in person at a polling station;

AND FURTHER TAKE NOTICE THAT an eligible voter in the Community of Délne or in Yellowknife who is infirm, ill, confined, or otherwise incapacitated and unable to attend a poll may access a mobile poll no later than four hours prior to the close of the polls on the voting day;

AND FURTHER TAKE NOTICE THAT the advance and final ratification votes will be held on the following dates between the hours of nine (9) a.m. and eight (8) p.m. at the polling booth(s) situated at the following locations:

Advance Polling Station:


